

## Property Release and Permission To Use Footage

Furthermore, I also grant the Photographer an unrestricted, royalty free and worldwide right to use for any purpose (except pornographic or defamatory), reproduce, prepare derivative works incorporating, publicly display, market, sublicense, sell and distribute and authorize others to use this Content, including the right of such others to sell, reproduce, publish, print, distribute, display, showcase and create derivative works of the Content in the form of edited, resized, resampled, transcoded, and/or cropped works, transmit, copy, and otherwise exploit, in whole or in part, in any medium now known or later discovered, including but not limited to by means of digital transmission through the Internet, including but not limited to all the Content taken of the said property by the Photographer, at the location and date(s) signified below.

I acknowledge and agree that the Photographer may use and exploit the Content in any manner, without

restriction of any kind, and without the necessity of acknowledging my or the property's identity, or by identifying me or the said property other than with my real name.

I hereby release and hold the Photographer harmless from and against all claims, suits, threats, demands, liabilities, actions and causes of action, in any way related to the Content or the Photographer's use and exploitation of the Content, including but not limited to actions based upon invasion of privacy, violation of moral rights, defamation, false light, and all other potential legal theories of any nature or type, under and state, federal or local common law, statutory law, rule, regulation or court order, whether now known and available or whether later developed, discovered or created.

This Release may only be amended or modified by way of a written agreement executed by the parties hereto or by the successors or legal representatives thereof.
